

## Wood End Primary School Public Sector Equality Duty (Updated June 2024)

#### Public Sector Equality Duty

#### **Characteristics of Wood End Primary School**

Wood End Primary School is a small primary school situated in North Warwickshire on the outskirts of Tamworth. Most pupils are of White British heritage with only 2 children speaking English as an additional language. The percentage of children eligible for free school meals is above national average.

In June 2024, no children on the child protection register, 1 child is Child In Need and four children are subject to Early Help, 1 child has been adopted from care. However, these figures are constantly changing.

Pupil mobility is relatively stable; 8 children have joined academic year 22/23 and 7 children have joined in 2023/24 (excluding nursery). All but one of the children that have left school this year have been as a result of house moves.

Such mobility often has an impact on continuity and progression of education for individual pupils.

The percentage of children eligible for free school meals is above average. In June 2024, 47 children were entitled to PPG (30%). 51 children (32%) were on the school's SEN register, 5 with an Education, Health and Care Plan (EHC Plan).

## Eliminating discrimination and other conduct that is prohibited by the Act
